#### MASSACHUSETTS ASSOCIATION FOR THE BLIND AND VISUALLY IMPAIRED RECEIVES GRANT FROM GIBNEY FOUNDATION FOR \$119,000

Brookline, MA, (April 22, 2019) – <u>The Massachusetts Association for the Blind and Visually Impaired</u> (<u>MABVI</u>) is pleased to announce it has received a \$119,000 grant from <u>The Gibney Family</u> <u>Foundation</u> (TGFF). TGFF partners with organizations to develop sustainable resources that foster independence, primarily for those who are blind. The funds will support MABVI's statewide volunteer program.

The grant, which will be distributed over the next three years, will enhance MABVI's statewide volunteer program through which individuals who are blind or visually impaired are matched 1:1 with community volunteers who provide in-home support. Trained volunteers help older adults accomplish daily activities of their own choosing including wellness activities, technology support, reading print information, shopping for groceries, or serving as sighted guides at the gym—all of which foster autonomy and enable older adults to remain active in their communities.

Over the past few years, the volume of MABVI volunteer requests has bourgeoned, as a growing number of aging adults experience vision loss but want to remain active. This three-year grant will allow MABVI to expand recent recruitment and retention solutions to meet the enormous need for volunteers, sustain its family volunteer program which involves youth in community service and blindness awareness, and design a new leadership initiative for volunteers and individuals with vision loss.

MAB CEO Barbara Salisbury expressed her sincerest appreciation for this grant award. "The Gibney Family Foundation's investment in MABVI over the years has had a profound impact on our ability to meet the needs of a growing number of individuals who are aging into vision loss. As a funding partner, they continue to play an important role in helping to shape robust healthy aging strategies for these individuals."

Sassy Outwater-Wright, MABVI Executive Director echoed these sentiments, sharing: "This multiyear commitment from TGFF will make a significant difference for MABVI as we work to expand access to in-home volunteer services for individuals with vision loss throughout Massachusetts, and pilot innovative peer leadership and advocacy roles to keep people engaged in their own communities."
